

# AMERICAN LEGION 7th and 8th GRADE SPEECH CONTEST

Sponsored by American Legion Post 43 PO Box 4, Naperville IL 60566 Contest Date January 20th, 2026

#### **Purpose**

Participation in this competition gives students a deeper knowledge and appreciation of the United States Constitution and furthers their research, essay writing, and public speaking skills. Entering this contest gives students valuable insight into the rights and privileges of American citizenship and the associated duties and responsibilities.

#### **Eligibility**

Contestants must be 7<sup>th</sup> or 8<sup>th</sup>-grade students in the general Naperville area attending any public, parochial or private school or homeschooled. They must be under the age of 15 on the date of the county contest (February 22<sup>nd</sup>, 2026)

#### **Contest Rules**

Each contestant will present a four to six-minute speech on some phase of the Constitution of the United States. The students will be judged on content (70 points) and speaking skills (30 points). Contestants will speak from a podium and should not read their speech but may refer to notes during the speech. They will be shown a time card at the 3, 4, and 5 minutes marks. If there is a violation of the time requirement, a penalty of one point per minute or fraction thereof will be assessed. Friends, family members, faculty and other interested parties may observe the speeches (no cheering or applauding permitted), but participants may not listen to the speech of a competitor.

#### **Post Level Competition**

The competition is limited to twelve participants. If more than twelve registrations are received, the first twelve based on date of email will participate. The final deadline for registrations is January 13th. Chicago Ave, Naperville, 2<sup>nd</sup> floor, at 6:00pm (students check-in at 5:30pm) on Tuesday, January 20<sup>th</sup>, 2026.

#### Awards

Post 43 awards are \$175 for 1<sup>st</sup> place, \$100 for 2<sup>nd</sup> place, and \$75 for 3<sup>rd</sup> place. All participants will receive at least \$25. Additional awards will be presented at the county level for students advancing from individual post competition.

#### **County-Level Competition**

Each post in the DuPage County may advance two students for judging in the County 7<sup>th</sup> and 8<sup>th</sup> Grade Speech Contest. The county competition will take place on Saturday, February 22<sup>nd</sup>, 2026 at the Visitor Center Theater at Cantigny Park, Roosevelt & Winfield Roads, Winfield, IL. Participants should check-in by 9:30 am and the competition will start at 10:00 am.
